IMPORTANT! PLEASE READ

Bourse Inclusions. Bourse fee includes a table (s), electric hookup, four chairs and one back up table. Safe is available at an additional charge. Exhibitor application is subject to acceptance by CK SHOWS. Table assistants MUST be employees or agents of the Exhibitor requesting badge. THIS POLICY IS STRICTLY ENFORCED. Exhibitors may share tables at NO CHARGE. All BADGE HOLDERS and TABLE SHARES must be submitted to CK SHOWS 45 days prior to the Show. Four (4) Exhibitor Badges per application. Lost or additional Badges are \$25. LIMIT four (4) Validations per show. It is unlikely that Exhibitor will be able to add tables to an existing location. Security and Liability. Armed Security will be present 12 noon Thursday to 6pm Sunday. Armed Security will be locked in the hall Thursday, Friday and Saturday evening. imdemnification.
